This document is circulated to the membership for comments to be sent to the Managing Director (mdirector@iptc.org) by the latest on 24 March 2006.

After that the Working Party has to decide on this submission at the IPTC Spring Meeting (27-29 March 2006).

There are literally thousands of file formats. It would seem an impossible task to try to record and manage them all in a single controlled vocabulary. Therefore my suggestion would be to deprecate the controlled vocabulary and make the NewsML format a free form text field.

To get a feel for the sheer number of file formats, here are a few file format lists from the Internet:

I could not find a definitive source for all file formats. The closest standard is the IANA list of officially registered MIME Media Types (<a href="http://www.iana.org/assignments/media-types/">http://www.iana.org/assignments/media-types/</a>). However media types aren't necessarily file format types. For example, there are several variants of GIF and many variants of XML.

If the IPTC has a requirement to continue the support of this topicset, then I would suggest that we modify the topicset according to the suggestions in the table below, then we augment the topicset with formats from a definitive source. I would suggest that we use Wikipedia "List of File Formats" resource as the definitive source <a href="http://en.wikipedia.org/wiki/List\_of\_file\_formats">http://en.wikipedia.org/wiki/List\_of\_file\_formats</a>.
