#### 4 Release of NITF 3.3

Alan Karben said NITF Version 3.3 is now publicly available at www.nitf.org. Two small, backwards compatible additions approved in London are:

- Changed content model for dd to include enriched-text
- Added data-location attribute back in for media-reference element (had been removed with NITF 3.0)

#### 5 NITF draft XML Schema

Alan Karben said he is working on a draft XML Schema, this is left to do:

- Transfer documentation over
- Migrate hard-wired controlled vocabularies out of Core XSD and into Schema Resource Files
- Debug a few trouble-spots

#### 6 Any Other Business

Alan Karben showed his draft specification for a very simple text mark up for articles called ArticleML and available at <a href="https://www.articleml.org">www.articleml.org</a>

His intention was to break out of the NITF specs the portions about marking up the text of an article to allow easier integration into the News Architecture (NAR). As the NAR provides all means for metadata the metadata related sections of the NITF specs are not required.

John Iobst proposed to provide a set of samples showing how text from an NITF instance can be transformed into ArticleML and how this markup can be integrated into a NewsItem from the NAR.

Alan Karben said he will work on such a set of examples.
