4 Promotion of IPTC standards

At the upcoming Nexpo a presentation on IPTC standards will be given at the NAA Wire Committee session; this will be on 21 June, 2.00 pm to 4.00 pm.

The presentations are prepared by John Iobst and the Managing Director and other IPTC members.

There is a plan to do the same at the IFRA Show in October in Amsterdam.

The main goal for both presentations is to introduce the standards, to push our NewsCodes and improve the use of Controlled Vocabularies.

Harald Löffler said he heard nothing about that plan yet and he will try to settle this with the organisers of the IFRA Show immediately.

5 Business case document

The Chairman said this was already covered in his report, the document is still missing.

6 IPTC publications and web sites

Regarding to item 5 the Managing Director said it would be of value to have business cases described by IPTC members also for our newsletter and for the standards-specific web sites.

The Chairman asked for proposals to improve the newsletter and the web sites, there were no responses to this.

7 Annual General Meeting press release

It was agreed to cover by this press release:

- making ProgramGuideML as Release Candidate
- the availability of the NewsML 1 Guidelines as draft

8 Any Other Business

The Managing Director proposed to agree on having the MD-account of Yahoo as a Co-Owner to all IPTC related forums – as there are still several groups where this account is only simple user or only a the Moderator level.

Motion: All IPTC standards related forums on Yahoo must have the account of the IPTC Managing Director ("mdiptc") as a Co-Owner.

This was proposed by Misha Wolf and seconded by Rudi Horvath.

Discussion:

Stéphane Guérillot said he thinks this is the wrong Committee to make such a decision.

Vote: On show of hands this was agreed unanimously.

NewsCodes:

The Chairman reported from the News Metadata Working Party a decision was made to introduce a brand name for all IPTC sets of metadata, it will be "NewsCodes".

Action ● The Chairman said he will work with the Managing Director on that by e-mail.

Klaus Sprick proposed to add a NewsCodes logo to the "TopicSetViewer" program.

Takahiro Fujiwara proposed to have a logo for NewsML too.

The Chairman said we should consider creating a group of logos like the W3C has.
