Action ● The NewsCodes Working Party should come up with a proposal for names for each individual set of NewsCodes.

The Managing Director added this page is currently not accessible from the IPTC portal page as here is an issue with the usage terms: the Management Committee discussed a language regarding how an adopter/implementer of IPTC standards has to comply with this standard. After this is clarified this language should be added to the terms of usage of the OK-buttons.

6 Review of IPTC web sites

Laurent Le Meur said he would like to see the information about updates of a standard in the centre region of the web page as people would be more aware of them this way.

The Managing Director added there is little hope to let everybody find what he wants as people are sending emails asking where to find information on standards that are cited in the head banner.

7 Review of IPTC printed publications (Mirror, etc.)

The IPTC editor Hugh Johnstone said he is currently working on the Spectrum 2004 and asks members to send information about applying IPTC standards to editor@iptc.org

8 Business Case document – appeal for submissions

The Chairman reiterated his invitation to send business case information to him.

The Managing Director asked the Chairman to provide a template as filing in such a skeleton might encourage members more than having to start from scratch.

Stuart Myles proposed not to wait for input but to make interviews with people known to have implemented IPTC standards.

Stéphane Guérillot said the presentation given by Kyodo News at the World Congress of News Agencies could be used as a business case.

9 Promotion of IPTC Standards

The Chairman pointed at the creation of the "IPTC Core" for XMP and the custom panels resulting from this work to be included into Photoshop CS. This will put IPTC in front of most of the photographers world wide and should provide a high profile.

10 Nexpo and Ifra presentations

The Chairman said reports about both presentations were already heard. These presentations have to be considered as an attempt to introduce a wider audience to the work of the IPTC.
